#### MFT Loss in Context

### Estimated annual MFT revenues under normal circumstances: \$2.595 billion

COVID-19 loss of \$184 million resulted in 7% loss

# Annual MFT revenues in FY19 (prior to Rebuild IL): \$1.359 billion

 Without the passage of Rebuild Illinois, COVID-19 impacts would've resulted in a 14% loss
